# Establishment of a Joint Venture Company (Subsidiary company) in the Philippines

**Tokyo, January 30, 2014** - CALBEE, Inc. (hereafter "Calbee") today announced a plan to establish a joint venture in the Philippines with Universal Robina Corporation (hereafter "URC"). Details are as follows:

#### 1. Purpose of joint venture

In line with our global strategy, we have decided to establish a joint venture company with URC which has strong sales and brands in the Philippine market. The joint venture aims to grow sales of Calbee products and expand market share in the Philippines, one of the promising snack foods markets. We will continue specific discussions with URC toward the establishment of the joint venture company.
